PV MODULE LIMITED WARRANTY POLICY

Effective on 24th Dec. 2024

LIMITED PRODUCT WARRANTY

"Product Warranty".

Changzhou EGing Photovoltaic Technology Co., Ltd (Hereinafter referred to as "EGing") warrants to the first buyer (Hereinafter referred to as "Buyer") the EGing Branded modules (Hereinafter referred to as "Product" or "Products"): During the limited warranty period, the original photovoltaic modules of EGing will not have quality problems of process and materials under the conditions of normal installation, use, operation, maintenance and environmental conditions, excluding stains, mechanical wear, rust, mold, deformation or discoloration of the Products, hereinafter referred to as

The Product Warranty period is 12 years as of the date of delivery from EGing's factory (In addition to EGing specified products). Neither the sales personnel of EGing nor any other person is authorized to extend the duration of any warranties beyond the Product Warranty as well as Power Output Warranty period on behalf of EGing.

For the specified Products listed below and only when they are installed on the residential rooftops, subject to the limitations & exclusions contained herein, The product warranty period will replace the 12-year limited warranty period specified above.

(1) EGing PV warrants to the Buyer that, for fifteen (15) years after the Warranty Start Date, the Products shall be free from defects in materials and workmanship which have an adverse effect on Products functionality under normal application, installation, use, and service conditions as specified in EGing PV's standard product documentation such as the installation manual and its annexes.

Upon acceptance of the claim, it is the commitment of EGing that it will, at its sole option, either repair or replace the defective Products with timely service at no charge to the Buyer or refund the purchasing value to the Buyer.

This Product warranty shall not cover any damages or defects which were caused by


repairs or attempted repairs performed by anyone other than EGing or its authorized service providers. All customers are kindly reminded to contact EGing only at any time for immediate service assistance.

POWER OUTPUT WARRANTY

The warranty period with respect to power output of the Products continues for a total of 25 (PERC single glass modules) \30 (PERC double glass modules & N-type single/double glass modules) years as of the date of delivery from EGing's factory. EGing warrants that, under the conditions of normal installation, use, operation, maintenance and environmental conditions, the Degradation Rate shall not exceed the amount for the applicable period following the warranty period as set forth below, hereinafter referred to as "Power Output Warranty". The Product Warranty and Power Output Warranty is hereinafter referred to as "Limited Warranty" collectively

A. PERC Monocrystalline single glass modules


For PERC Monocrystalline single glass modules: not exceed 2% degradation in the first year, and 0.55% per year thereafter, ending at 84.8% in the 25th year after warranty start.



B. PERC Monocrystalline double glass modules


For Monocrystalline double glass modules: not exceed 2% degradation in the first year, and 0.45% per year thereafter, ending at 84.95% in the 30th year after warranty start.






C. N-type Monocrystalline single glass modules

For Monocrystalline single glass modules: not exceed 1% degradation in the first year, and 0.4% per year thereafter, ending at 87.4% in the 30th year after warranty start.



D. N-type Monocrystalline double glass modules

For Monocrystalline double glass modules: not exceed 1% degradation in the first year, and 0.4% per year thereafter, ending at 87.4% in the 30th year after warranty start.



This Power Output Warranty is transferable provided the Products remain installed in original location and within the aforesaid warranty period. EGing will, at its option, repair or replace the product, refund the purchase price, or provide the Buyer with additional modules to make up lost power, provided that such degradation is determined to be due to defects in materials or workmanship. The relevant Minimum Specified Power Rating is defined in EGing's product label at the time of shipment.

REMEDIES

If the Buyer believes that the moduels do not meet the requirements of this product

warranty, it shall notify EGing in time and within 30 days. The notice should contain the

following information: (a) Claimant; (b) Detailed description; (c) Supporting materials,

including photos or data;(d) Serial number of the moduel; (e) Warranty start date;(f)

Module type; (g) Location; (h) Other supplementary supporting materials required by

EGing; (i) Provide moduels that do not meet the the requirements of product warranty

according to the requirements of EGing.

In the event that the quality defect or non-conformity of the Products is attributable to

EGing, EGing will, at its sole option, repair, replace and/or refund such Products. The

repair or replacement of the Products shall not constitute the beginning of a new

warranty, nor does it extend the original warranty, but continues to calculate the

remaining warranty period of the original Products. If the Products to be replaced have

been discontinued, EGing has the right to, within the scope of reasonable efforts, use

the same or similar models of modules to implement such replacement.

EGing is responsible for the direct costs of repair and replacement in addition to the

freight for transporting the repair, replacement and/or additional Products to the Buyer

only. For avoidance of doubt, EGing shall not be responsible for the removal,

re-installation, insurance, customs clearance and other work of the relevant Products.

LIABILITY LIMITATION

The limited warranties set forth herein are expressly in lieu of and exclude all other

express or implied warranties, including but not limited to warranties of merchantability

and of fitness for particular purpose, use, or application and all other obligations or

liabilities on the part of EGing PV, unless such other warranties, obligations, or liabilities

are expressly agreed to in writing and approved by EGing PV.

The warranties described above shall be sole and exclusive warranties provided by

EGing PV and shall be the sole and exclusive remedy available to the purchaser,

unless otherwise agreed and approved by EGing PV in writing.

EGing PV's aggregate liability, if any, in damages or otherwise, shall not exceed the

invoice value as paid by the purchaser.

EGing PV shall have no responsibility or liability whatsoever for damage or injury to

persons or property, or for other loss or injury resulting from any cause whatsoever

arising out of or related to the product, including, without limitation, any defects in the

module, or from use or installation.

The repair of replacement of the modules or the supply of additional modules does not

cause the beginning of new warranty terms, nor shall the original terms of this warranty

be extended or reset. The replaced modules shall become the property of EGing PV,

EGing PV has the right to deliver another type (different in size, color, shape and/or

power) in case EGing PV discontinues producing the replaced modules at the time of

the claim. In the mean time, EGing PV will exert reasonable efforts to deliver a similar

or equivalent type of modules.

ITEMS EXCLUDED FROM WARRANTY COVERAGE

The Limited Warranty coverage does not apply when:

A) The module are modified, damaged, defaced or is improperly transported, installed,

abused or used inappropriately;

B) The modules are installed in a mobile or marine environment, subjected to improper

voltage or power surges or abnormal environmental conditions (such as acid rain or

other pollution);

C) The components in the construction based on which the modules is mounted are

defective;

D) External artificial corrosion, mold discoloration or the like occurs;

E) Defects caused by the modules being subjected to any of the following: extreme

thermal or environmental conditions or rapid changes in such conditions, corrosion, oxidation, unauthorized modifications or connections, unauthorized opening or repair,

repair by use of unauthorized spare parts, accident, force of nature (such as lightning strike), influence from chemical product or other acts beyond EGing PV's reasonable

control (including but not limited to damage by fire, flood, etc.);

F) Incidental, consequential or special damages such as loss of use, loss of profits,

revenues, business, goodwill, damage to reputation or expenses payable to a third

party.

FORCE MAJEURE

Where there is the force majeure category of issues including but not limited to acts of

God, war, riots, strikes, unavailability of suitable and sufficient material, capacity and/or

any unforeseen events beyond the control of EGing after reasonable efforts, EGing shall

not be responsible for non-performance or delay in performance of the duties under this

Limited Warranty.

SEVERABILITY

If a part, provision or clause of this Limited Warranty, or the application thereof to any

person or circumstance, is held invalid, void or unenforceable, all other provisions

contained in this Limited Warranty shall not be affected and accordingly shall remain in

full force and effect.

DISPUTE SETTLEMENT

Any dispute related to or arising out of this Limited Warranty, including without limitation

any question regarding its existence, validity, breach, or termination, shall be referred to

and finally resolved pursuant to the governing law clauses and dispute resolution

procedures under the purchase agreement between the Buyer and EGing. As a condition

to perform any obligation of EGing hereunder, EGing may require any customer seeking

to enforce this Limited Warranty to execute an additional agreements as may reasonably

be required to enforce the terms.

MERGER CLAUSE

This Limited Warranty sets forth the entire agreement and understanding of the Parties

relating to the subject matter herein and supersedes any and all prior or

contemporaneous discussion, understanding and agreement, whether oral or written,

between them relating to the subject matter hereof.

MISCELLANEOUS

The terms of this Limited Warranty constitutes the premise of the contractual agreement

between EGing and Buyer upon the Producs, and when any conflict or discrepancy with

such contractual agreement, this Limited Warranty shall prevail. EGing reserves the right

to modify or update this Limited Warranty at any time, with or without notice.

CLAIM WARRANTY

If the Buyer feels a justified claim covered by this Limited Warranty, an immediate

notification directly to EGing shall be filed. Together with the notification, the Buyer

should enclose the evidence of the claim with the corresponding serial number of the

Products as well as the documents of purchasing. EGing will determine in its sole

judgment the adequacy of the claim.

Warranty claims shallnot be honored if the type or serial number of the Products have

been altered, removed or made illegible.

Notwithstanding anything to the contrary herein, EGing shall be entitled, in EGing's sole

discretion upon written notice to the Buyer, to require that any breach of the Warranties

alleged by the Buyer be reviewed by TÜV Rheinland, TÜV SUD or other neutral third

party testing laboratory selected by EGing and approved by Buyer, such approval not to

be unreasonably withheld or delayed ("Independent Testing Lab"). The power

measurement tolerance of any testing equipment utilized by any Independent Testing

Lab in performing tests required shall be disclosed in writing to both Parties prior to

performance of any such tests and shall be reflected in any final test results provided by

the Independent Testing Lab. The determination by an Independent Testing Lab as to

whether a breach has occurred shall be final and conclusive with respect to the matters

covered by such determination. EGing shall be responsible for all costs incurred by it in

connection with the shipment by Buyer of a Product pursuant and any Independent

Testing Lab's services provided pursuant, including shipping, testing services, storage,

insurance and any Product destruction incidental thereto provided, however, Buyer shall

promptly upon receipt of notice indemnify EGing for all such costs on a dollar-for-dollar

basis in the event the Independent Testing Lab is unable to confirm a breach of the

Warranties or, if no Independent Testing Lab was utilized, the Buyer is otherwise unable

to establish a breach of the Warranties. The final explanation right shall be borne by

EGing.

In case of replacement, upon receiving the notification from EGing in writing for return of

the Products involved for warranty claim, the Buyer can ship the Products back to EGing,

if the Buyer ships the Product, it is required that the replaced Products are insured and

packaged for the kind for of transportation chosen by the Buyer. Transportation charge, customs clearance or any other costs for return of the replaced or repaired Products or costs related to installation, removal or re-installation of the Products shall be borne by the Buyer. Upon approval from EGing, all reasonable costs relating to logistics will be reimbursed by EGing. EGing will provide all necessary services and assistance and ensures fast response from the time of claim is launched to the time the claim is settled.

This Limited Warranty applies to modules to be delivered after the Nov 1st 2023.
